In accordance with Education Article §15-106.1(d), the Maryland Higher Education Commission (MHEC) presents the information below on Maryland Foster Care Tuition Waiver recipients and Maryland Unaccompanied Homeless Youth Tuition Waiver recipients. The statute requires the collection of the number of enrolled students who (1) received the specified tuition exemption during the prior academic year; (2) received the specified tuition exemption at any point during their enrollment at the institution; and (3) earned a bachelor's degree, associate degree, or certificate from the institution during the prior academic year. The following data are an aggregation of submissions provided by all public postsecondary institutions in the State.

Student totals are not provided, as individual recipients may have received awards over multiple years.

In total 27 public postsecondary institutions (16 community colleges and 11 public four-year institutions) awarded the Foster Care waiver to students from July 1, 2018 to June 30, 2019. Similarly, 23 public institutions (13 community colleges and 10 public four-year institutions) awarded the Unaccompanied Homeless Youth waiver in the reporting year.

- The majority of the recipients of the Foster Care waiver were enrolled at Maryland's community colleges. Conversely, a greater number of recipients graduated from the public four-year institutions in 2019 than public community colleges.
- Unaccompanied Homeless Youth waiver recipients were evenly distributed among Maryland's public institutions in 2019.
